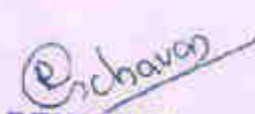


**A report on Two Days National Seminar on "Regulatory Perspectives of Product Development" at Allana College of Pharmacy, Pune**

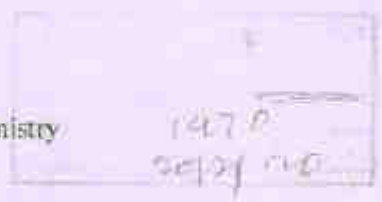

**A report on Three Days International Seminar on "Recent trends in Chemometrics: A Pharmaceutical Perspective" organized by MIT, WPU School of Pharmacy in Association with All India Technical Education (AICTE), New Delhi.**

I the undersigned have attended three days International Seminar on "Recent trends in Chemometrics: A Pharmaceutical Perspective" organized by MIT, WPU School of Pharmacy in Association with All India Technical Education (AICTE), New Delhi on 6<sup>th</sup> to 8<sup>th</sup> February 2020 at Hotel Sheraton, Pune. The report for the same is as follows.

The first day session started with inauguration ceremony at the hand of Dr. Richard Brereton. In his key note address he mentioned the recent trends in Chemometrics and explained its importance. The session continued with his talk on Type 1, Type 2 errors and false discovery rates: History, Controversy and applications in modern pharmaceutical science. He discussed origin of idea of p values and significance test. He elaborated the relationship between p values and false discovery rates. Plenary session II was continued after post lunch by Dr. Erdal Dinc, Faculty of Pharmacy, Ankara University, Turkey. He explained the analysis of drug substances in pharmaceutical systems. He also emphasized on PARAFAC model and its applications to three way data array of pH absorbance. Later Dr. Marcel Meader discussed various chemometric methods which included factor analysis, evolving factor analysis partial least square method, process analytical technology and enzyme kinetics.

Next day session began with the stimulating talk by Dr. Kunal Roy, Dept. of Pharmaceutical Technology, Jadavpur University, Kolkata. He mentioned in his talk that computational tools like QSAR models are the only way to screen large sets of chemicals in short time. Mr. Rajshekhar Tomad, Director, Program Management and Head COE New Technologies in MSAT, Dr. Reddy's Lab Hyderabad continued his talk on Continuous Manufacturing: An emerging process technology for pharmaceutical products. Dr. Suresh Kumar, Dr. Jayant Khandare shared their expertise in the field of Chemometrics. Oral presentation competition was held during these sessions in conference hall. I have presented research work on "In Silico design, synthesis, and biological evaluation of some quinazolinone derivatives as potential antimicrobial agents". On the last day Dr. Anirudha Deshmukh discussed Multivariate analysis derived model. Dr. Renato Lajarin Carneiro explained Chemometrics for risk assessment in quality by design.

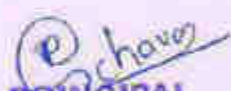

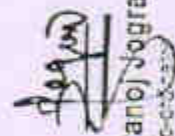
